Patrick Ciaschi is a Ph.D. Candidate in the Politics department at the New School for Social Research (NSSR). From 2016-17 he was a Visiting Researcher at the University of Debrecen's Lippai Balázs Roma Szakkollégium, and more recently a 2017-2018 Visiting Scholar at the Balsillie School of International Affairs' (BSIA) International Migration Research Centre (IMRC).

Alexandra Clavé-Mercier is a social anthropologist and an associate researcher at Centre National de la Recherche Scientifique (Centre Emile Durkheim, UMR 5116). She teaches at Université de Bordeaux, France. She has carried out researches on minority subjectivities and marginalized migrant or native groups such as Roma and Travelers (Gens du Voyage) in France, Bulgaria and Romania, with a focus on the institutional dynamics in schooling, social policy and housing. She is author of several articles, books chapters and co-editor with Isabelle Rigoni of a special issue "Enquêter sur les migrations", in *Migrations Société* (2017).

Judit Durst is a Hon. Research Fellow at the University College London, UK, in the Department of Anthropology, and a senior researcher at the Institute for Minority Studies of the Hungarian Academy of Sciences. She has been a Bolyai Postdoctoral Research Fellow and later on a visiting lecturer at the Institute of Sociology and Social Policy of Corvinus University, Budapest. She has been a faculty member on CEU Summer University's Romany studies program for many years. She has got her PhD degree in Sociology, writing about exclusion, poverty and ethnicity in rural Hungarian 'ghetto' villages in the region of Borsod, Hungary. She has been a team member of some international comparative research projects. Her main research interests are ethnicity, poverty, reproductive decision-making, anthropological demography and lately economic sociology; Roma migration and social mobility. She has been a member of the Scientific Committee of the European Academic Network on Romany Studies.

Jan F. Gamella is an anthropologist, and professor of Anthropology at the Universidad de Granada. He did his doctoral training at the Universidad Autonoma de Madrid, and at the University of California, Santa Barbara. Has done fieldwork in Sumatra (Indonesia) on cultural and ecological change brought up by the growth of the oil industry, as well as in several regions of Spain and in the US on drug and alcohol use and trade, and on heroin abuse and AIDS. Since 1993 he has been studying different elements of the Gitano or Calé culture of Spain, particularly in long-term project on the ethnographic and demographic ethnohistory of the Cale population of Andalusia. Since 2003 he has also researched the transnational migration of Romanian Roma. He has been visiting researcher at the University of California at Santa Cruz (2010-2011), the University of Cambridge (2001-2002), and the Johns Hopkins University (1997-1998).
